Payment for services is due at the times services are rendered. We accept cash, checks and most major credit cards (Master Card, Visa and Discover). Returned checks and balances older than 30 days may be subject to additional collection fees and interest charges of 1.5% per month. A \$20.00 CHARGE WILL BE ASSESSED FOR BROKEN APPOINTMENTS AND APPOINTMENTS CANCELLED WITHOUT A 24 HOUR ADVANCE NOTICE.

We will gladly discuss your proposed treatment and answer any questions relating to your insurance:

You must realize however, that

- 1. Your insurance is a contract between you, your employer and the insurance company. We are not a party to that contract.
- Our fees are generally considered to fall within the acceptable range by most companies, and therefore are covered up to the maximum allowance determined by each carrier.
- 3. Not all services are a covered benefit in all contracts. Some insurance arbitrarily select certain services they will not cover.
